
A leading provider of corporate bonds for small and mid-sized companies.



BASEL III – BONDS AND MEZZANINE FINANCING

After the Financial crisis of 2008/09 the Basel committee decided to impose Basel III, a global regulatory framework on bank capital and liquidity. The framework contributes to financially stronger banks in the event of a new financial crisis, but as a consequence, banks have become more restrictive with lending to small and mid-sized companies. The new regulation has made it harder to obtain loans at favourable terms and many companies are instead looking to the bond or mezzanine loan market for financing.

PROJECT MANAGEMENT

Through JOOL Markets AS, JOOL has the role of financial adviser, structuring the transaction and coordinating all involved parties including trustees and legal advisers.

Legal adviser

Conducts legal Due Diligence and provides legal documentation.

Auditor

The auditor verifies the correctness of financial information from the issuing company.

Trustee

The role of the trustee is to protect the rights of the lenders and to ensure that the issuer complies with its obligations under the loan terms. If necessary, the trustee can take legal action on behalf of lenders.



LEGAL ADVISER

All transactions are subject to a Due Diligence (DD), carried out in cooperation with the legal adviser in the transaction, usually Roschier Law Firm.

The process is based around a number of key questions:

• Which parts of the issuing company are most important for generating and maintaining cash flows?



Financial DD (JOOL)




HOW ESCROW ACCOUNTS PROTECT THE INVESTOR

- During the transaction, the loan proceeds are deposited in a secure escrow account prior to being transferred to the issuer.
- Once all loan conditions are met and collateral has been pledged, the Trustee approves final transfer of the loan proceeds to the issuer.
- A disbursement shedule ensures that loan proceeds are used for the intended purpose (for example a property acquisition).
- Lenders receive interest on their investment from the issue date, regardless of whether the loan proceeds have been transferred to the issuer.







TRANSACTION VOLUMES




Total volumes of direct loans, bonds and insurance structured and marketed/placed by the JOOL Group since 2012.


BONDS AND DIRECT LOANS - NUMBER AND VOLUMES



PAYMENTS (SEK M)


